In the Netherlands, the Immigration and Naturalisation Service released a new working instruction 2022/3 for the assessment of the credibility of conversion and apostacy in response to the ruling of the Council of State of 19 February 2022 (see further on). The Dutch Gave Foundation, a NGO whose expertise re religion based asylum claims is acknowledged, reported that the new procedures for apostacy still lack clarity and

On 29 September 2022, The Dutch Council of State ruled that IND must improve its procedures for subsequent asylum claims after a conversion had been judged incredible in a previous procedure. An important aspect is, that the subsequent application can shed a new light on the claimant's statements of the previous procedure.

## 17. Other important developments in 2022

The Dutch Immigration and Naturalisation Service made some effort to seek external expert advice on religious issues. However, the consultancy process lacks transparency and seems to lack serious commitment. A Parliamentary motion of 7 July 2022, asking the Secretary of State to speak with external stakeholders and experts and to submit a proposal for the use of expert advice, was not followed up by the requested actions. A subsequent Parliamentary motion of 14 November 2022 is still pending further discussion. In spite of what the Secretary of State writes in his letter to Parliament of 4 November 2022, he seems not much inclined to accept structural input from external experts for the improvement of procedures and for the training of case workers re religion based asylum claims. In fact, in 2022 the Immigration and Naturalisation Service (IND) decided not to use webinars that the Gave Foundation developed on request and in agreement with the IND.
