Input by civil society to the EASO Annual Report on the Situation of Asylum in the EU+ 2018

EASO has started the production of the 2018 Annual Report on the Situation of Asylum in the European Union, in line with Article 12 (1) of the EASO Regulation. The report aims to provide a comprehensive overview of important asylum-related developments at EU+ and national level, and the functioning of all key aspects of the Common European Asylum System (CEAS). Previous reports are available at EASO's website

While the final product comes out of an analytical and synthetic process that takes place in-house, a critical part of information is elicited through valuable contributions by a multiplicity of stakeholders from EU+ countries, civil society organizations, UNHCR, and other actors possessing in-depth knowledge on main developments in asylum policies and practices in EU+ countries.

We would like to kindly invite you to take part in this process, by sharing your observations on developments in asylum law, policy or practice in 2018 (and early 2019) in the areas listed on the online survey. The topics listed there reflect the structure of Chapter 4 of the EASO Annual Report, which focuses on the 'Functioning of the CEAS'. As of 31 December 2018 there were 10,787 (1) unaccompanied minors (including many applicants for international protection). According to the Italian law it is necessary for every minor to have a guardian, who is an important figure to exercise rights, including those involving international protection. The Law 7 April 2017 n. 47 (2) established the list of voluntary guardians at the Juvenile Courts and the)
Legislative Decree 22 December 2017 n. 220 (3) transferred the jurisdiction concerning the appointment of guardians to the aforementioned Courts.	,
There have been 5,501 citizens who have given their consent to become a guardian, but those appointed to the Juvenile Courts are much les (4)s. In May 2018 the Italian Ombudsperson for Children and Adolescer complained about the slow pace in appointment procedures (5)	-
